**Subject:- Enhancement of Mess Expenditure on Students in JNVs.**

Sir,

The mess expenses for students are reviewed periodically to increase the norms of expenditure as per requirements so as to ensure provision of adequate diet to the growing children. Last revision of norms for mess expenditure of students was made w.e.f. 1<sup>st</sup> April, 2012 and it was communicated vide circular F.No. 5-4/2009/NVS (SA) Dated: 16-02-2012.

With the approval of the Finance Committee of Navodaya Vidyalaya Samiti at its 59<sup>th</sup> Meeting held on 01st June, 2016 and Executive Committee of Navodaya Vidyalaya Samiti at its 34th Meeting held on 27.06.2016, the existing norms of Mess expenditure on students is enhanced as under:-
