The Examination Application Forms (EAF) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and submitted to the Examination Branch duly signed by the student and the principal concerned along with photocopy of qualifying examination (user manual is enclosed). Xerox copies of Examination Application Forms & Photographs will not be considered.

#### **Fee Structure:**

*Examination fee 870 + Processing fee Rs.300 + Memorandum of Marks charges Rs.60/- total fee is Rs.1230/-.*

**Fee paid once cannot be refunded or adjusted for any future examination.**

#### **Note:-**

The candidates are advised to enclose xerox copy of **B.Ed (MR) / (HI) Degree Certificate** duly attested by the Principal concerned. The candidates who qualified B.Ed(MR) from **other than OU** have to submit the **Migration Certificate in Original and Migration fee of Rs.125/-** along with their application form other than Osmania University candidates.

As a part of the Core Banking System, all the students are hereby instructed to deposit Examination fee into their respective College Principal's account only (students are advised not to obtain the DD in favour of the Controller of Examinations, OU).

The concerned Principal's are requested to deposit (credit) the Consolidated Examination fee amount into **"Registrar, Osmania University Examination fee Fund A/c No:52198262033" in any branch of State Bank of Hyderabad** and obtain a receipt from the bank and submit the same to the Examination Branch, OU along with application forms.

The Principals are requested to verify and forward all the Examination application forms received by them immediately as per the given schedule along with the **namelist, fee particulars & subject-wise data in duplicate** on the next day i.e., **09-02-2015**.

A penal fee of **Rs.1,000/-** per day shall be levied if the colleges fails to submit the application forms within the stipulated date i.e., on or before **09-02-2015**

All the candidates who are appearing the M.Ed (MR) & (HI) Examinations should write the exams only in the English as per the University Orders.
