3. **The Blind, Physically Disabled, Deaf & Dumb students** (who have 40% of minimum Disability) **need not to pay Examination Fee** as per O.U Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. **A Xerox Copy of Medical Certificate** must be attached to the EAF.

4. a) **ALL THE REGULAR CANDIDATES OF I & III-SEMESTER SHOULD SUBMIT THEIR EXAMINATION FORMS THROUGH ONLINE ONLY.**

- b) **The College will be held responsible for any mistake committed while filling the candidate name, mother name, father name and paper title (Theory & Practical) through ONLINE. IN CASE OF ANY MISTAKE RS.1000/- will be levied as FINE for rectification of each error.**

The other University candidates should enclose their **Original Migration Certificate together with a fee of Rs.150/-** in addition to the examination fee.

5. The Clearance certificate from Nodal Officer, Statistical Cell, O.U.
6. **Annexure-I** signed by the candidates and concerned Principal.
