**Note** :- Fresh candidates who are appearing for Examinations, i.e., **B.A.[Languages]-First year of Rs.200/-** and **M.A.[Languages]-Previous of Rs.300/-**-should pay “ **EXAMINATION PROCESSING FEE**” in addition to the examination fee (one time fee to be paid in the 1st year only).

**The candidates who are appearing for Osmania Entrance, PDC-II year, B.A.[Languages] -III year and M.A.[Languages]-Final year Examination should pay Rs.60=00 extra along with the Exam fee for Provisional Certificate.**

**Candidates from other Board/Universities should enclose their Original Migration Certificate together with a fee of Rs.125/- in addition to the Examination Fee.**

The Examination application forms of I , II & III year eligible students (i.e., admitted to I year during the academic year for Osmania Entrance 2013-2014, Pre-Degree-Course 2011-2012, B.A.[Languages] 2009-2010 & M.A.[Languages] 2011-2012 onwards) of the academic year 2013-2014 are to be submitted online through college login. Also, hard copy of the same may be downloaded and submitted to the Examination Branch duly signed by the student and the Principal concerned along with photocopy of Qualifying Examination.

As per the Rules of the University, candidate admitted to Osmania Entrance, Pre-Degree-Course, B.A.[Languages] & M.A.[Languages] courses must complete the course of study as duly registered candidate in double the duration of the course. They are however, eligible to appear for their backlog papers only on payment of Rs.1000=00 per paper in addition to the normal Examination Fees as detailed below:-

OSMANIA ENTRANCE.....2011-2012 & 2012-2013 Batch

PRE-DEGREE-COURSE.....2009-2010 & 2010-2011 Batch

B.A.[LANGUAGES].....2009-2008 & 2008-2009 Batch

M.A.[LANGUAGES].....2009-2010 & 2010-2011 Batch

All the Colleges under the Nalgonda , Nizamabad & Mahaboobnagar District are required to submit the Examination application forms of Backlog candidates to Osmania University.

NOTE:-As a Part of the **Core Banking System**, all the students are hereby instructed to deposit the examination fee into their respective college principal's accounts only (students are advised not to obtain the DD in favour of the 'the Controller of Examinations')

#### **IMPORTANT NOTE:-**

All the College principals are requested to deposit (Credit) the consolidated examination fee amount into **"Registrar, Osmania University Examination Fee Fund A/c No.52198262033"** In any branch of State Bank of Hyderabad and obtain a receipt from the bank and submit the same to the examination branch along with examination forms.

The candidates who are appearing for Improvement, they must clearly mention on their Application form **FOR IMPROVEMENT** otherwise their application will not be considered for Improvement as per the existing norms.

The prescribed Examination application forms can be obtained from the Director, University Press, Osmania University, Hyderabad-7, on payment of Rs.10=00 in person or by post on payment of Rs.60=00 drawn in favour of the Director, University Press, Osmania University.

The Application forms not accompanied by the required Xerox copies of Memo of Marks attested by the concerned Principal of earlier Examinations are liable to be rejected.

**( 2 ) FURTHER, IT IS CLARIFIED THAT THE RESULTS OF SUCH CANDIDATES WHO ARE NOT ELIGIBLE TO APPEAR FOR THE EXAMINATIONS WILL BE CANDELED AT ANY STAGE**

**(a) Without and with penal fee Examination application forms have to be submitted in the Examination Branch, O.U. by 27-01-2015 and 02-02-2015 respectively with the Nominal Rolls along with a statement of subject wise strength.**

- (b) The Principals of the colleges are requested to enclose **"NO DUES CERTIFICATE"** and a copy of the Affiliation extension order for the year 2013-2014 with sanctioned strength issued by the Academic Branch, O.U. and **"CLEARANCE"** from the DIRECTOR, ACADEMIC AUDIT CELL, O.U. Otherwise their Examination forms will not be accepted.
- (C) **Approval from the Nodal officer, Statistical cell, Administrative Building, O.U**
- (d) One hard copy of nominal rolls (Consolidated list of candidates) generated using the Students online information System after due verification by the Principal And I year Nominal Roll signed by the Director, Directorate of Academic Audit, O.U.
- (e) Fees Abstract (in duplicate) the first copy to be submitted to the Deputy Registrar (Cheque-II Section), Examination Branch, O.U. and the second copy to the concerned sections.
- (f) Forward only the Examination Application forms of the candidates who have put in required percentage of attendance.
- (g) **Candidates who have applied for Revaluation/Recounting also have to pay the Examination fee as per the above schedule without waiting for the results of Revaluation/Recounting as the case may be.**
- (h) The Examination fee once paid by the candidate will not be refunded or adjusted.
- (i) **A Penal Fee of Rs.500=00 per day** shall be levied if the college fails to submit the examination application form(s) with in the stipulated date(s) mentioned above.
- (j) The Principal(s) are responsible for certifying and forwarding the wrong information, if any, by the Candidates.
