Further after remitting the Examination fee into Registrar Examination Fee Fund Account through Core Banking system the Colleges can obtain a receipt from the Bank and submit the same to the Examination Branch along with Examination Forms.

The Principal is requested to forward all the Examination forms duly certified on or before 31.03.2015 without fail. Forms received after 31.03.2015 will be levied penal fees of Rs.1000/- per day.

The Principal is requested to verify the eligibility of the candidates for admission to the above course and forward the examination application form duly certified.

Further, the Principals are requested to enclose the list of admitted candidates for the year 2014-2015 signed by the Director, P.G. Admissions along with the candidates submit 2 (two) soft copies and 2 (two) hard copies. Approved copy from Academic Audit Cell, O.U. and clearance certificate from Nodal Officer, Statistical Cell, O.U.
