Application Forms submitted by the colleges after $\underline{29-07-2015}$ will have to pay a penal fee of Rs. 1000/- per day. N O T E :

1. The students are advised to enclose Xerox copies of their qualifying examination certificate attested by the College Principal concerned with the Examination Application forms and Migration Certificate, if any, with **Migration Fee of Rs.125**/-(if the candidate belongs to other than T.S. Intermediate Board).

2. As a part of Core Banking System , all the students are hereby instructed to deposit the Examination Fee into their respective College Accounts only for onward Transmission to the University by the college.

3. The Principals are requested to furnish the list of candidates admitted in their Colleges during the academic year 2014-2015 duly approved by the Convener, **EAMCET and also the Director, Admissions, O.U.**

4 In respect of I Year fresh admissions the colleges have to get clearance letter from the

Director, Academic Audit Cell, O.U. and the examination application forms of I Year students admitted during the academic year 2014-2015 are to be submitted online through college login..Also, a hard copy of the same may be downloaded and submitted to the Examination Branch duly signed by the student and the Principal concerned along with **photocopy of Intermediate / 10+2 certificate**.

5. The Principal is requested to verify the eligibility of the students thoroughly and forward the same to this office for the UPLOAD Hall Ticket. If failed to verify the eligibility of the candidates, the principal is held responsible for the issue of hall ticket by this office to the non-eligible candidates.
