- 1. All the candidates who have registered for 2011-2012 and 2012-2013 Batch for the Ph.D. Course Work Examinations are eligible to write.
- 2. The Examination Application Forms (EAF) are required to be submitt online through college login. Hardcopy of the EAFs to be downloaded and submit at the Examination Branch duly signed by the candidate and the Supervisor, Head, Dean concerned along with photocopy of qualifying examination
- 3. The Heads are requested to collect the Examination Fee from the candidates. Duly verified *ONLINE EXAMINATION APPLICATION FORMS* received from the candidates are requested to submit on or before <u>29-02-2016</u> along with Nominal Roll, with consolidated FEE statement and Titles of Paper-II in duplicate

### Fee Structure: -

- 1. <u>The Prescribed Examination fee is Rs.220 + Rs.60/- (Memo of Marks) +</u> i.e. Total fee of Rs.280/- (for 2011-2012 and 2012-2013 Batches)
- 2. <u>2009-2010 and 2010-2011 BATCH BACKLOG CANDIDATES HAVE</u> TO PAYRS.1,000/- PER EACH PAPER ALONGWITH EXAM FEES

#### <u>Note:-</u>

- The concerned Principal's are requested to deposit (credit)/transfer the Consolidated Examination fee amount into <u>"Registrar, Osmania University</u> <u>Examination fee Fund A/c No:52198262033" in any branch of State Bank of</u> <u>Hyderabad through NEFT/RTGS</u> and obtain a receipt from the bank and submit the same to the Examination Branch, OU along with application forms. No Demand Drafts are accepted at core Banking section at the Exam Branch, OU.
- 2. The Backlog candidates are advised to enclose the Xerox copies of their latest Memorandum mark memo.

- 3. All the candidates are advised to enclose the Xerox copies of **Qualifying course Certificate & Joining Report and Migration Certificate** (Original with a fee of Rs.250/-) for the candidates who have done their PG in the Universities other than OU.
- 4. The Principals are requested to pay the examination fee for the received Application Forms and not to pay the fee for not-received Application forms. Any excess fees paid for un-received application forms is not refundable <u>Individual demand drafts</u> <u>submitted by the students will not be accepted.</u>
- **5.** The Principal is informed to enclose the following documents along with the Application forms:

  - II. Titles of Paper-II (Specialization Paper) in duplicate Subject wise.
  - III. Allot Separate Roll numbers for Part time & Full time Candidates and also separate numbers (Year code) for two different academic years.
