### <u>NOTE:</u>

As per the Rules of the University, candidate admitted to Osmania Entrance, Pre-Degree Course & B.A.(Languages) courses most complete the course of study as duly registered candidate in double the duration of the course. They are however eligible to appear for their backlog papers only on payment of Rs.1000/- per paper in addition to the normal Examination Fees, <u>Within Next Two (2) years</u> immediately after the prescribed period of study (i.e double the duration of the course).

### **GENERAL CONDITIONS TO THE PRINCIPALS**

The Examination Application Forms (EAF) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and submitted to the Examination Branch duly signed by the student and the Principal concerned along with photocopy of qualifying examination (user manual is enclosed). Xerox Copies of Examination Application Forms & Photographs will not be considered.

The University has decided to accept the payment of Examination fee through Core Banking system from the Colleges under Osmania University jurisdiction as communicated vide. Lr.No.171207/COE/2007, dated 17-12-2007. The Core Banking system has come into effect from 01-04-2008 onwards.

The Colleges those maintaining their account with the branches of State Bank of Hyderabad can remit the fees through the same branch of **credit of Registrar**, **Osmania University Examination Fee Fund** <u>A/C No. 52198262033</u> maintained with **Osmania University Branch of State Bank of Hyderabad.** 

In case the College is maintaining its account with any Bank other than State Bank of Hyderabad they are required to deposit money/cheque in favour of the Registrar University examination fee Fund **A/C No. 52198262033** in any Branch of State Bank of Hyderabad for credit.

# <u>Under any circumstances CASH/Demand drafts will not be</u> <u>accepted. It is required to transfer the fee amount through RTGS / NEFT for</u> credit into Registrar Osmania University Exam Fee Fund A/c No 52198262033 (SBH, O.U.Branch, IFSCode "SBHY0020071")

Further after remitting the Examination fee into Registrar, Examination Fee Fund Account through Core Banking system the College can obtain a receipt from the Bank and submit the same to the Examination Branch along with Examination Forms.

The Principals of the colleges are required to furnish the **Subject wise data** in the Prescribed Performs and submit the examination forms in the Office of the Controller of Examinations as per schedule stated above.

The Principals of the Colleges have to observe the following :

(a)The Students are advised to enclose the photo copies of their previous examination memorandum of marks duly attested by the college principal concerned along with the examination application forms.

(b) Candidates who have applied for Revaluation also have to pay the examination fee as per the above schedule without waiting for the results of Revaluation as the case may be.

(c) The Candiates who are appearing for improvement must clearly and mention on their Application form as <u>FOR IMPROVEMENT</u> otherwise, their application forms will not be considered for Improvement as per the existing norms.

(d) Fees Abstract (in duplicate) the first copy to submitted to the Deputy Resgistrar (Cheque-II Section), Examination Branch, O.U. and the second copy to the concerned sections.

(e) The Examination fee once paid by the candidate will not be refunded or adjusted.

(f) <u>A Penal Fee of Rs.1000=00 per day</u> shall be levied if the college fails to submit the examination application form(s) with in the stipulated date(s) mentioned above.

(g) The Principal(s) are responsible for certifying and forwarding the wrong information, if any, by the candidates.
