- 2. PRE-DEGREE-COURSE I YEAR .. Rs.730/- +Rs. 50/- (For Memo) ... Total Fee Rs.780/-
- 3. **B.A.[LANGUAGES] I YEAR**...Rs.595/- + Rs.50/- (For Memo) & + Rs.200/- towards Examination Processing Fee (one time fee to be paid in the Ist year only). **Total Fee Rs.845**/-

GENERAL CONDITIONS TO THE STUDENTS:

Candidates are advised to mention their Address and Father's & Mother's Name, as per qualifying examinations certificate in the Online Examination application forms without fail. After wards no correction will be considered.

GENERAL CONDITIONS TO THE PRINCIPALS

The Examination Application Forms (EAF) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and submitted to the Examination Branch duly signed by the student and the Principal concerned along with photocopy of qualifying examination (user manual is enclosed). Xerox Copies of Examination Application Forms & Photographs will not be considered.

The University has decided to accept the payment of Examination fee through Core Banking system from the Colleges under Osmania University jurisdiction as communicated vide. Lr.No.171207/COE/2007, dated 17-12-2007. The Core Banking system has come into effect from 01-04-2008 onwards.

The Colleges those maintaining their account with the branches of State Bank of Hyderabad can remit the fees through the same branch of **credit of Registrar**, **Osmania University Examination Fee Fund A/C No. 52198262033** maintained with **Osmania University Branch of State Bank of Hyderabad.**

In case the College is maintaining its account with any Bank other than State Bank of Hyderabad they are required to deposit money/cheque in favour of the Registrar University examination fee Fund **A/C No. 52198262033** in any Branch of State Bank of Hyderabad for credit.

<u>Under any circumstances CASH/Demand drafts will not be accepted. It</u> is required to transfer the fee amount through RTGS / NEFT for credit into Registrar Osmania University Exam Fee Fund A/c No 52198262033 (SBH, O.U.Branch, IFSCode "SBHY0020071")

Further after remitting the Examination fee into Registrar, Examination Fee Fund Account through Core Banking system the College can obtain a receipt from the Bank and submit the same to the Examination Branch along with Examination Forms.

The Principals of the colleges are required to furnish the **Subject wise data** in the Prescribed Performs and submit the examination forms in the Office of the Controller of Examinations as per schedule stated above.

The Principals of the Colleges have to observe the following:

- (a) Without and with penal fee Examination application forms have to be submitted in the Examination Branch, O.U. by **29-02-2016** & **08-03-2016** respectively with the Nominal Rolls along with a statement of subject wise strength.
- (b) The Principals of the colleges are requested to enlclose "NO DUES CERTIFICATE" and a copy of the Affiliation extension order for the year 2015-2016 with sanctioned strength issued by the Academic Branch, O.U. and "CLEARANCE" from the DIRECTOR, ACADEMIC AUDIT CELL, O.U. otherwise their Examination forms will not be accepted.
- (c) Approval from the Nodal Officer, Statistical cell, Admintrative Building, O.U.
- (d) One hard copy of nominal rolls (Consolidated list of candidates) generated using the students online information system after due verification by the principal and I year Nominal Roll signed by the Director, Directorate of Academic Audit, O.U.
- (e) Fees Abstract (in duplicate) the first copy to submitted to the Deputy Resgistrar (Cheque-II Section), Examination Branch, O.U. and the second copy to the concerned sections.
- (f) Forward only the Examination Application froms of the candidates who have put in required percentage of attendance.
- (g) The Examination fee once paid by the candidate will not be refunded or adjusted.
- (h) A Penal Fee of Rs.1000=00 per day shall be levied if the college fails to submit the examination application form(s) with in the stipulated date(s) mentioned above.
- (i) The Principal(s) are responsible for certifying and forwarding the wrong information, if any, by the candidates.
