

**HIGH COURT OF ANDHRA PRADESH :: HYDERABAD**

**NOTIFICATION ROC.NO.3/2012-RC**

In Supercession of earlier Notification in Roc.No.3/2012-RC, dated 15.5.2012  
the following notification is issued.

\*\*\*\*\*

The High Court had published a list of candidates who were declared to have been qualified in the screening test conducted on 29.04.2012 for recruitment to the cadre of Civil Judge. Subsequently, objections were received that the key answers to certain questions are incorrect.

In the light of the representation received, the matter was re-considered by the Committee of the Hon'ble Judges of the High Court and by a decision taken on 8<sup>th</sup> June, 2012, the Committee resolved that the answers to question numbers 24,30,35,41,49,55,62,72,81,82,83 and 94 as given in the key are incorrect. Accordingly, it was decided to re-evaluate the answer sheets on the basis of 87 questions (Question No.22 was deleted earlier) by deleting the above 12 questions (in total 13) and to prepare a fresh list of candidates who have qualified in the screening test.

The fresh list is given below: -

**Note:** As a result of the re-evaluation, the 26 candidates under Direct Recruitment having Registered Numbers 1190, 1258, 1360, 1698, 1867, 2205, 2219, 2254, 2520, 2611, 3318, 3518, 3553, 3898, 4582, 4596, 4796, 4809, 5046, 5131, 5378, 5509, 5559, 5952, 6085 and 6087, who were earlier declared to have been qualified in the screening test were eliminated. To avoid any prejudice to them due to re-evaluation, their names have been included in the list of qualified candidates and 92 candidates under Direct Recruitment having Registered Numbers 1017, 1068, 1247, 1254, 1544, 1662, 1667, 1672, 1725, 1749, 1869, 1907, 1912, 2075, 2124, 2126, 2226, 2248, 2258, 2379, 2385, 2397, 2941, 2511, 2528, 2587, 2679, 2732, 2790, 2836, 2840, 2885, 3015, 3065, 3084, 3096, 3412, 3478, 3485, 3492, 3502, 3533, 3547, 3651, 3691, 3732, 3737, 3745, 3775, 3811, 3812, 3867, 4012, 4121, 4271, 4313, 4314, 4425, 4449, 4467, 4471, 4479, 4503, 4525, 4715, 4732, 4764, 4770, 4834, 4872, 4894, 5025, 5148, 5177, 5303, 5326, 5345, 5380, 5453, 5703, 5708, 5731, 5742, 5795, 5820, 5848, 5884, 5949, 6005, 6141, 6161 and 6170, who have secured same marks and fall in the same category of those above 26 candidates have also been declared qualified in the screening test.

Similarly, the 2 candidates under recruitment by transfer having registered numbers 5898, and 6025 who were earlier declared to have been qualified in the screening test were now eliminated. To avoid any prejudice to them due to re-evaluation their names have been included in the list of qualified candidates and 9 candidates having registered numbers 1801, 4493, 4494, 5067, 5084, 5897, 5901, 6192 and 6194 who have secured same marks as that of the above 2 candidates, have also been declared qualified in the Screening Test”.

“It is, however, clarified that permission to appear for the written examination does not entitle the candidate to participate in the subsequent stage, if at a later stage, the candidate is found ineligible and his/her application is found to be defective, he/she shall not be entitled to participate in the further process of the recruitment.”

**Note:**

1. The application with Regd.No.3566 is rejected, as the applicant is over aged.
2. The application with Regd.No.4121 is granted 15 days time for submitting attested copy of SSC or Equivalent Examination in proof of his Date of Birth.
3. The grounds for rejection of applications with Regd.Nos.2011, 2211,3575, 3406, 5264 and 3141 and other information relating to Regd.Nos.1402, 2482 and 4106, kept in the High Court's Official website earlier, holds good.

**Date, Time and place of written examination:**

The written examination will be conducted on **Sunday the 5<sup>th</sup> day of August, 2012 at Hyderabad from 10.00 a.m. to 1.00 p.m.** Hall Tickets will be dispatched to the qualified candidates in due course. If any candidate does not get hall ticket by 2.8.2012, he/she can contact the Recruitment Cell.

The revised marks lists of all candidates is also placed in the High Court's official website.
