- IV. Creamy Layer exemption certificate from Revenue authorities for BC candidates only, as per G.O.Ms.No.3, BC Welfare (C2) Dept., dt. 04/04/2006 who claim reservation under BC Community
- V. Study Certificates from IV class to X class if studied in school or Residence certificate for 7 years prior to appearing in SSC, if appeared for SSC as a private candidate.
