Emoluments :-

At present, initial monthly emoluments of Middle Management Grade/ Scale II Officers, including DA, HRA & CCA are approximately ` 34,000/- per month in a Metropolitan Centre. Allowances may vary depending upon the place of posting. In addition, Quarters facility (in lieu of HRA) for Officers, Conveyance, Medical Aid, LTC and retirement benefits are admissible, as per rules of the Bank, in force from time to time. The selected Candidates will be covered under Defined Contributory Pension Scheme.

PROBATION PERIOD :- The selected candidate will be on probation for a period of **12 months** (-1- year) of active service from the date of his/ her joining the Bank. There is **no mandatory provision of executing a Service Bond** by selected candidates.

RESERVATIONS :- As per Government Guidelines.

SELECTION PROCEDURE :-

- A personal interview shall be conducted to assess the candidate's personality, level of communication, clarity & problem solving ability, Knowledge of the subject area, innovativeness, level of efficiency, willingness to work in any part of the country, suitability for the post etc. <u>The minimum qualifying marks would</u> <u>be 40% for General Category and 35% for Reserved Category</u>. Candidates not clearing the personal interview will not be considered for final selection.
- 2. The candidates belonging to SC/ST/OBC/PWD will be given relaxation in age eligibility, as per extant Government guidelines.

INTERVIEW CENTRES:-

The interviews are being held in Delhi and Mumbai.

CALL LETTERS FOR INTERVIEW :-

Call letters for the purpose of interview is being sent to all shortlisted/ eligible candidates <u>through email as well as through Post at the email</u> address/Correspondence address given by them in the application form.
