In continuation to the result notice dated 06.12.2010, 14.06.2011 and 26.12.2011, the result in respect of the following candidates was kept pending for various reasons such as verification of handwriting/signature, completion of documents etc. which was processed based on their merit in written examination and qualifying the skill test by the candidates.

The vacancies for the post had been advertised by the Board vide its advertisement No. 003/2009 with closing date of receipt of application as 02.12.2009

On completion of verification as regards to the genuineness of the candidature and scrutiny of documents submitted by the candidates, the result in respect of following candidates is finalized and candidates are selected provisionally to the post of Driver(DTC), Delhi Transport Corporation in the Pay Scale of Rs. 3200-4900 (Pre-revised) under the Post Code – 65/09, subject to their passing the medical examination requiring HEIGHT – 162 Centimeters (Minimum) and VISION – 6/6 without glasses and no color blindness and as per the medical standards for driver prescribed by the D.T.C:-

Regarding the admissibility of benefit of the reservation, the result has been processed as per the judgment dated 04.08.2009 of Hon'ble Supreme Court of India as passed in the Civil Appeal NO. 5092 of 209 arising out of Petition(s) for special leave to Appeal (Civil) No.s(s) 24327/05 Subhash Chandra & Ors. Versus DSSSB & Ors.

The Driving Skill Test Evaluation Boards as per provisions of RR's of the post, requiring the candidates to hold a valid Heavy Motor Vehicle License for at least three years, have considered candidates who possessed valid HTV Driving License as on 03.12.2006 i.e. three years prior to the cutoff date, eligible to appear in the skill test and declared the candidates passed subject to verification of their Driving Licenses. As such, the nomination as above shall be subject to the candidate's producing proof of issue/endorsement of their HTV

driving license of period 03.12.2006 and prior to that date. In respect of the candidates whose particulars as recorded in application form for the post varies to the particulars as indicated in the driving license, the Board is nominating the candidates to the post with clear stipulation that the veracity of driving license of such candidates shall be got verified from the RTO concerned, by the DTC authorities, before issue of offer of appointment.

As per the provision of the RR's, selected candidates, who do not possess PSV Badge issued/endorsed by STA-Delhi, will have to obtain the same within 3 months of their selection and this time period could further be extended by DTC on merits. However, the driver would actually start on line duty in DTC only after the required PSV badge is issued to him.

The Selection of above 11 candidates (UR-07, SC-03, OBC-01) shall further be subject to these candidates found fulfilling the eligibility conditions for the post, up to the satisfaction of the appointing authority, for which documents as submitted with application forms, at the time of driving skill test and on the directions of the Board, as placed in respective dossiers, shall be verified by the DTC authorities from the original ones and also subject to verification of genuineness of candidature of the candidates thorough signature/thumb impressions, as put up by the candidates in their application forms, admit cards of written as well as skill test examination and handwritten submission obtained during driving skill test and in the Board.

The candidature of the 5 candidate with roll number 6535243, 6541681, 6543206, 6543286 and 6547988 is kept pending and they will be called separately in the office of DSSSB for verification of genuineness of their candidature.

The candidature of 06 candidates with Roll No. 6512954, 6540284, 6545279, 6546219, 6546742 and 6546836 is hereby rejected on the grounds that these candidates failed to respond to the directions of the Board.

The candidatures of the 03 candidates with Roll No. 6532397 6539417 & 06541468 are hereby rescinded on the grounds that they were found involved in the malpractices in the examination.

The candidature of 01 candidate with Roll No. 6529828 is hereby rescinded on the grounds of violation of terms and conditions of the advertisement for the post as he has put his signatures in capital letters in all the documents i.e. application form, admit cards, OMR sheet etc.

The candidature of one candidate with roll number 6538905 is also rescinded on the grounds that application form submitted by him was not filled in his own handwriting and the same was filled up by some other person which is violation of terms and conditions of the advertisement for the post. Further, father's name of the candidate differs in application form, and his signature found mismatched on the affidavit filed by the candidate.

While every care has been taken in preparing the result, the DSSSB reserves the right to rectify the errors and omissions, if any.

This result notice is issued as per the approval of the Competent Authority, DSSSB.
