**RESULT NOTICE**  
**JUNIOR ENGINEER (POST CODE -002/09)**  
**DELHI JAL BOARD**

This is in compliance of the directions of the Hon'ble CAT vide its orders dated 22-07-2013 in MA No. 3077/2012 & 3078/**2012** in OA No. 3749/2010 titled Sunil Malik vs. GNCTD & Ors. wherein it has been directed that:-

"10.....Since now it is established that the contention of the 2<sup>nd</sup> respondent (DSSSB) made in his order dated 09-01-2012, purported to be passed in compliance with the orders of this Tribunal, that there are no vacancies is factually incorrect, and on the other hand, it is established and admitted that 15 vacancies of JE (Civil) under OBC category are available, the respondents are duty bound to pass appropriate follow up orders by considering the case of the applicant for appointment as Junior Engineer (Civil) in the available post in OBC category, as directed by this Tribunal in its order dated 12-08-2011 in OA No. 3749/2010."

"11. In view of the aforesaid discussion, the MA 3077/2012 is disposed of with a direction to the respondents to give full effect to the order dated 12-08-2011 in OA No. 3749/2010 of this Tribunal, in the light of the aforesaid observations within a period of 6 weeks from the date of receipt of a copy of this order. No costs."

In view of the above directions, the following candidate is provisionally selected and recommended for appointment to the post of Junior Engineer (Civil), Post Code 002/09 in Delhi Jal Board under OBC category in the pay scale of Rs. 5000-8000 (Pre-revised).

The selection of the above 01 candidate (OBC-01) shall further be subject to fulfillment of all the eligibility conditions as prescribed by the statutory RR's and terms and conditions of advertisement as indicated in the advertisement inviting applications and also subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application forms, admission certificates etc., the candidature of the candidates are liable to be cancelled by the user department also, in case the candidate is found not to be fulfilling the eligibility conditions or due to any other genuine reason. The user department shall also get the OBC certificate verified from the issuing authority before his appointment. Further, it may also be verified that the candidate does not belong to the persons/section (Creamy layer) mentioned in column 3 of the Schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt.(Res) dated 09.03.2004 and O.M. No. 36033/3/2004-Estt.(Res)dated 14.10.2008.
