

Recruitment of Scale I Officers (Assistant Manager) in GIC Re

- 1. The selected candidates are expected to confirm their willingness of their acceptance of this offer by way of e-mail before 18th September 2013, (contact e-mail ids are provided below) if no reply received within the cutoff date, it will be deemed to be considered that the candidate is not willing to accept the selection offer and their selection shall stand cancelled.
- 2. The selected candidates, who expressed their acceptance within the prescribed time limit, will be sent with the offer letter along with copy of service bond as per our advertisement; by way of e-mail as well as by conventional post. The medical fitness certificate to be obtained from the prescribed medical practitioner at our training center.
- 3. The candidates will be advised to report at our training center, Pune in second or third week of November 2013 for medical fitness. While reporting to the training center, the candidates are expected to produce their original qualification certificates including additional qualifications, original caste certificate issued by the competent authority in the format prescribed by the Central Government.
- 4. It is expected that candidate should submit copy of their pan card. It is also advisable to produce a copy of Passport and the originals for verification at the time of joining. In addition candidates are required to keep minimum six copies of their passport size colour photographs.
- 5. The offer can be cancelled at any point of time if the produced certificates are in not in order / not in acceptable conditions.
- 6. Those who are employed presently shall produce the proper reliving letter from the previous / current employer at the time of joining.
- 7. Upon satisfaction as per above terms and conditions, the candidates, from whom the medical fitness certificate is received, will be issued with the appointment order and advised to report at our training center, Pune next day for the induction training.
- 8. From the date of offer letter, more than one month time is being given for the candidate to report at the training center, no further extension of time will be given as the scheduled training program commences uniformly for all candidates.
- 9. The candidates are expected to stay in the training center for about 3 months, both lodging and boarding will be provided in the training center by GIC Re. Upon completion of the induction training the candidates are expected to report at the Head Office of GIC Re in the first or second week of February 2014.
