2. The cut-off percentage of marks in the above Preliminary Examination is as follows:

- (i) OBC vacancies: 45% in each component and 115 marks in aggregate
- (ii) SC vacancies: 40% in each component and 122 marks in aggregate.
- (iii) ST vacancies: 40% in each component and 111 marks in aggregate
