Candidates must bring Diploma/Degree etc. certificate of respective discipline. Candidates must possess the qualifying educational qualification on the date of original application. SC, ST & OBC candidates must bring their Caste Certificate on prescribed proforma duly issued by competent authority as appeared on the employment notice. In case of OBC candidates, the Caste certificates should be current and should have clause of non-creamy layer.
