On the basis of first stage written examination held on 15.07.2012, Aptitude test held from 10.10.12 to 18.10.12 and verification of candidature and documents from 11.02.13 to 26.02.13 for the above mentioned post, the candidates listed in ANNEXURE –I (against normal vacancy) and ANNEXURE – II (against GDCE vacancy) have been provisionally found successful for empanelment for the above post. All the candidates have been allotted to SEC Railway. The Roll numbers are given ascending order.

All successful candidates are also being advised individually.

If at a later date, any candidate is found to be debarred by any RRB or any discrepancies/irregularities detected in respect of qualification, age community etc, then his candidature/appointment will be cancelled.
