This includes the originals of all certificates whose xerox copies were attached with the application form for various categories of Junior Engineer/DMS (b) vacancies are available (c) they pass prescribed medical examination (d) complete the requisite administrative formalities/procedures and (e) their thumb impression, photograph, signature, handwriting and other details in their applications match before appointment/actual joining.

All successful candidates are also being advised individually.

If at a later date, any candidate is found to be debarred by any RRB or any discrepancies/irregularities detected in respect of qualification, age community etc, then his candidature/appointment will be cancelled.

This is a part panel. The final panel for remaining categories (normal and GDCE) will be published in due course.

Similarly, the category wise list indicating Roll Numbers of candidates in ascending order who were lower in merit and could not be considered for empanelment due to non-availability of vacancies in the respective category/community, although they were called for document verification is attached as <u>ANNEXURE-II</u>.
