NOTE:

1. The offer of appointment for empanelled candidates against open advertisement quota will be issued in due course subject to verification of all relevant original records.

2.Each candidate appointed on sports quota has to submit undertaking/excute bond that he will serve the SEC Railway for a minimum

period of 05 years as per extent rules. The policy instructions issued by Railway Board from time to time will apply for the above recruitment.

3. Each candidate will be required to pass medical examination stipulated for the post offered to him/her.

4. Each candidate will have to maintain standards to his/her performance in the sports against which he/she has been empanelled failing which he/she is liable for the removal from service.

5. Sportsperson recruited against sports quota shall be terminated from service, if the information and documents furnished by him/her for recruitment, are found incorrect/fake at any stage; observing requisite procedure for such information.

6. Post once offered will not be changed. The place of posting of the candidates will be put-up on the website of South East Central Railway, at www.secr.indianrailway.gov.in in due course.
