Recruitment of Sub-Inspectors in Delhi Police, CAPFs, Assistant Sub-inspectors in CISF Examination, 2013–Declaration of result of the candidates of <u>re-examination</u> held on 25.08.2013 etc. found qualified for appearing in PET/Medical Examination and Paper-II-reg.

The Staff Selection Commission conducted a Written Examination for Recruitment of Sub-Inspectors in Delhi Police, CAPFs and Assistant Sub-inspectors in CISF on 23.06.2013 at different centers across the country. The result of Paper-I was declared on 29.08.2013. However, result of 1636 candidates of the said examination could not be declared due to discrepancies/mismatch in their data.

- 2. For some candidates of CR & NR region (Bareilly & Haridwar), the Commission conducted **re-examination** on **25.08.2013**. 1560 candidates appeared in this examination.
- 3. Based on the cut off already fixed by the Commission, following are the details of candidates qualifying for PET/Medical Examination and Paper-II from the above candidates: (Male candidates)

- 4. It has been decided that Paper-II of the above examination will be held on 06.10.2013(Forenoon). PET and Medical Examination is tentatively scheduled to be held in the month of October, 2013. Candidates are advised to follow the websites of Regional Offices regarding admit cards.
- 5. The category status in respect of the candidates belonging to reserve categories has been indicted alongwith their roll numbers. It is important for such candidates to note that they may have been declared qualified only for the category mentioned against their Roll Number or his roll numbers or where the roll number and name do not match, he/she may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to contact immediately the respective Regional Offices of the Commission in all such cases.

- 6. Candidates may note that as per notice of the examination and instructions given in the OMR answer sheets, they were required to code/write their particulars correctly and append their signature/LTI on the answer sheets. Such answer sheets which are without signature/LTI and where particulars such as name, roll number, ticket number and test form number were coded incorrectly, have been rejected/awarded ZERO marks.
- 7. Qualified eligible candidates who do not receive the Admission Certificate for Paper-II examination at least 7 days before the commencement of the said examination or are unable to download from respective regional office website should immediately contact the respective Regional Office of the Commission.
- 8. Marks of the qualified/non-qualified candidates of Paper-I will be uploaded shortly.
