4. Any appeal against rejection of candidature will not be entertained.

The expression Matriculation/Higher Secondary Examination Certificate in this part of the instructions includes the alternative certificate mentioned above. 15. In case of age relaxation being Government Servant - certificate issued after the date of advertisement from his/her employer on office's letter head (in the prescribed format at Proforma-VII of the Advertisement No. 09/2013 (Item No. 52, Vacancy No. 13070952113) published in the Employment News dated 13.07.2013 to the effect that he/she is a regularly appointed Central Government/UT Government servant and not on ad-hoc/daily wages/hourly paid/contract basis employee etc. should be furnished.
