  - (i) Matriculation/High School Examination Certificate or Equivalent certificate (Proof for Date of Birth and Matric Qualification).
  - (ii) NCVT/SCVT/ Diploma Certificate (As applicable).
  - (iii) Caste Certificate for SC/ST - Annexure-3.
  - (iv) Caste Certificate for OBC - Annexure-4.
  - (v) Income Certificate for Waiving Examination Fee - Annexure-7.
  - (vi) Medical Certificate for Persons with Disabilities (PWD) - Annexure-9.
  - (vii) NOC from serving employees/Ex-Servicemen.
  - (viii) Minority declaration on Non-judicial Stamp Paper.
  - (xi) Two recent passport size colour photographs.
  - (x) Two sets of attested copies of all original certificates.
4. Candidates, who are already **serving employees** in any central / State Government Department including Railways or public sector undertakings, are required to produce **No Objection Certificate (NOC)** from the employer during document verification without fail.  
Note: Candidates should note that in case a communication is received from their employer by the RRB concerned withholding permission to the candidates applying for/ appearing at the examination, their candidature is liable to be rejected / cancelled.
