<u>UG MEDICAL (MBBS) COUNSELING - 2013.</u>

(SECOND ROUND COUNSELING TO BE HELD ON 31.08.2013)

The1st round of counseling for admission to UG Medical (MBBS) course to JSS Medical College, Mysore was conducted on 01.07.2013 and 02.07.2013.

Consequent to the Letter of Permission by the Medical Council of India, New Delhi, order No. MCI-37(1)(1-2)/2013-Med/20134 dt. 10.07.2013 permitting JSS Medical College, Mysore, to increase the intake from 150 to 200* for the academic year 2013-14.

University has scheduled the second round of counseling for admission to MBBS courses for the academic year 2013-14, against the seats available.

Note:

- Those candidates among the JSS University UG Medical Rank list 2013 (JSSU UGET 2013), who had appeared in the first round of counseling (Rank from 01 to 300), held on 01.07.2013 and 02.07.2013 and have been waitlisted are only eligible to attend the second round of counseling.
- If the candidate does not report on the specified date and time, his
 / her application will be deemed cancelled without any further
 notice and they shall forfeit any claim for counseling and admission
 thereof.

Bio-metric Identification:

- All candidates will be required to participate in Bio-metric identification. The thumb impression made in JSSU UGET 2013 Invigilators dairy will be compared with that of the applicant appearing for counseling. If any discrepancy is observed and if there is sufficient evidence of impersonation, appropriate action as per the prevailing laws will be taken. Only eligible and properly identified candidates will then be permitted to proceed to the next stage of verification of original certificates.
- If the photographs, fingerprints and signature of the candidate obtained in the process of JSSU UGET 2013 entrance test, invigilators diary and counseling and admission do not tally, this act shall be deemed as attempt of impersonation due to which the candidate shall be summarily disqualified and legal action initiated.

COUNSELING VENUE:

You are requested to report to the **JSS Medical College, Sri Shivarathreeshwara Nagar, Mysore – 570015, Karnataka** for counselling, as per the Schedule announced.

At the time of counseling, the candidates shall submit their original documents and prescribed tuition fee compulsorily for allotment of seats. Without original documents / Prescribed Tuition fee, candidates will not be allowed to attend the counseling for selection of seats.

Following Original Certificates along with the 3 sets of photocopy are to be produced:

- 01. JSSU UGET 2013 TAT card
- 02. JSSU UGET 2013 score / rank (Downloaded copy of result from JSSU Website: www.jssuni.edu.in
- 03. S.S.L.C./Equivalent examination marks card.

- 04. 10+2/ II P.U.C./Equivalent examination marks card.
- 05. B.Sc.,/Equivalent examination all the three years marks cards (in case of graduates)
- 06. Conduct/Character and Transfer certificate issued by the college last studied.
- 07. Date of birth certificate if not mentioned in the SSLC/Equivalent examination marks card.
- 08. Caste / community certificate (The certificate issued by competent authority)
- 09. Physical fitness certificate issued by a Medical Officer not below the rank of Assistant Surgeon.
- 10. Transfer certificate for Karnataka board candidates
- 11. Migration Certificate issued by the Board /University in case of candidates studied other than Karnataka State Board.
- 12. Six Passport size photo's, of which one to be affixed to the application form in space provided.
- 13. An affidavit in the format signed by self and countersigned by Parent / Guardian in the presence of Notary Public on a stamp paper of Rs.50/-(ANNEXURE IV of the Brochure)
- 14. DD's (of Nationalized Bank) for Tuition fees drown in favour of: "The Principal, JSS Medical College, Mysore", payable at Mysore.

Admission date & Commencement of Class:

- ♣ The selected candidates would be required to get admitted to the college on or before 2nd September, 2013.
- ♣ The classes for the said admitted candidates will begin from 2nd September, 2013.

GUIDELINES

<u>The following guidelines are brought to the notice of the prospective students:</u>

- 1. The Candidate is required to submit all the original documents / certificates and the requisite course fee to the University for the Confirmation of admission at the time of counseling. The University will not accept any acknowledgement / Receipt copy of submission of the documents to the other University / Organization.
- 2. If the student forfeit's his / her seat after August 31, 2013 and on or before September 25th, 2013, he / she will have to forfeit the course fees for first year paid by them.
- 3. Any surrender of seats after September 25th, 2013, would involve the student having to pay the full course fee of Four and Half years, as the consequent vacancy created by such forfeiture cannot be filled by the University.
- **4.** The students are required to immediately report for class, failing which the seats will be deemed forfeited without any further information.
- 5. Candidate must be physically present and no proxy registration will be accepted.

Legal Jurisdiction:

- Any dispute that may arise in respect of the seat selection process and admission is subject to the jurisdiction of the Civil Courts of Mysore.
