2. **As a part of the interview, you will first be given a 5-7 minutes time for power point presentation on your work done in the last 3-5 years for the post of Headmaster (On Deputation), therefore please bring with you CD, Pendrive etc. for presentation.**
3. Your candidature for interview is provisional subject to production of aforesaid documents, failing which you will not be allowed to appear before the Selection Committee and no TA will be paid.
4. As regard the travelling expenses payable by the Council for claiming 3rd AC train fare to-and-fro (except Rajdhani, Shatabadi, Duranto etc. trains) or actual fare, whichever is less, will be paid on production of Railway/Bus Tickets.
