2. You are being summoned for an Interview subject to production of Documents/Certificates in original (along with attested Photocopies) which were mentioned in Advertisement No. SPL/51/2012, Item No 01 dated 14.04.2012 and detailed below.

- i. Matriculation/Xth Standard or equivalent certificate indicating date of birth OR Matriculation/Xth Standard or equivalent Marksheet issued by Central/State Board indicating date of birth.**
- ii. - vii. Physically Handicapped Certificate in prescribed format (for PH candidates)

The photographs should, prima facie, appear to have been taken within the preceding one month. On the reverse of the two photographs you should write in ink your (i) Roll Number, (ii) Date of interview; and (iii) the name of the Post. Only the Upper-half should be utilized for writing Roll Number etc., and the Lower half should be left blank for Official use.

NOTE- :- Closing date i.e. 03.05.2012 is crucial date for receipt of application as all claims of Essential Qualifications/Age Relaxation / Community etc. are governed by the closing date.
