Candidates should produce all certificates in ORIGINAL viz (1) EAMCET-2012 Rank card & Hall ticket (2) Memorandum of Marks of Intermediate or its equivalent (3) Memorandum of Marks of SSC or its equivalent (4) Study Certificates from 7th Class to Intermediate (5) Residence certificate for preceding seven years of the qualifying examination i.e. Intermediate in respect of candidates who had private study without any institutionalized education (6) Residence Certificate of Father or Mother for a period of 10 years in A.P. excluding the period of their employment outside A.P. from M.R.O. in case of Non local candidates. (7) Minority Candidate whose parental Income is less than Rs.1 Lakh are exempted from the payment of Tuition Fee, provided they furnish the Income Certificate issued by MRO on or after 01.01.2012 to an extent as prescribed by the Govt.

Fee Particulars:

Tuition fee Rs.35000/- p.a. for B.Tech / B.Pharmacy Courses. In addition, candidates will have to pay Rs.300/- and Rs.600/- towards Registration & Counseling fee respectively.

Fee shall be remitted as Demand Draft drawn in favour of "Convener, EAMCET-AC-SW-II-2012 Admissions" payable at Hyderabad or in cash at the bank counter available at the venue. Fee shall be paid in full at the time of counseling and no part payment will be accepted.

Candidates are informed that they should satisfy the admission rules prescribed by the respective universities and should be prepared to pay the Tuition Fee as applicable. The above fee structure is subjected to any enhancement by the Govt. More number of candidates are called for counseling than the seats available. Hence mere attending the counseling does not guarantee the student a seat.
