#### How to Calculate 20% TET weightage in AP DSC 2014 (TET cum TRT) Exam

As per the instructions of AP DSC 2014 Notification, DSE has made it clear that 20% weightage will be given for Earlier AP TETs. Now there is a doubt that, "how this 20% weightage Will be calculated in this AP DSC 2014 (TET cum TRT) Written Exam". We know that, Basing on ths weightage, final seniority Lists will be prepared. Let us see what is given in the notification "Candidates shall be selected on the basis of marks secured in the Written Test. The candidates who have already qualified in earlier APTETs also compulsorily write the above Integrated Test for appointment as Teacher in Government / Zilla Praja Parishad / Mandal Praja Parishad/Municipality/Tribal Welfare Schools. These candidates will be given 20 % of weightage for their earlier TET score (as per the original TET notification). For this 20% weightage, candidates will be having option either to consider 20% of earlier TET scores or 20% of present marks whichever is higher.

Now onwards, the integrated Test will be valid for that particular recruitment only. In respect of appointments in private / un-aided schools or any other educational Institutions, the Integrated Test Certificate will be valid for a period of 1 (One) year. A Certificate will be issued to the candidates who are fulfilling minimum requirement in the above Integrated Test by obtaining minimum qualifying marks prescribed at Rule 6."

Hence let us see the method of calculation of 20% weightage:

Formula for Calculating TET Weightage:

If Your Earlier 20% TET Weightage is more than 20% of DSC 2014 TERT Exam, then the Difference will be added to the APDSC 2014 Score, if TET 20% Weightage is less than APDSC 2014 20% Weightage, then the APDSC 2014 Score will continue.

# **Example 1:**

AP TET obtained Marks: 120 AP TET Total Marks: 150

Calculation for  $20\% = (120/150) \times 20 = 16$ 

Hence Your APTET Weightage in this DSC is 16 Marks

Let us assume that you have obtained 140 Marks out of 200 Marks School Asst Exam. AP DSC 2014 Obtained Marks 140

Total AP DSC Marks: 200

Weightage of  $20\% = (140/200) \times 20 = 14$ 

Now Your Weightage in **APTET is MORE than 20% of present AP DSC**. Hence Your Total Marks will be (Your Obtained DSC Marks + (20% of APTET - 20% APDSC) = 140+2=142. Total Score is 142.

## Example 2:

AP TET obtained Marks: 100 AP TET Total Marks: 150

Calculation for  $20\% = (10/150) \times 20 = 13.33$ 

Hence Your APTET Weightage in this DSC is 13.33 Marks

Let us assume that you have obtained 115 Marks in 180 Marks SGT Exam.

AP DSC 2014 Obtained Marks 115

Total AP DSC Marks: 180

Weightage of  $20\% = (115/180) \times 20 = 12.77$ 

Now Your Weightage in APTET is LESS than 20% of present AP DSC. Hence Your Total Marks will be Your Obtained Marks 115 only.
