- Fee for Vocational candidates is Rs 60/- in addition to Regular Examinations fee of Rs:125/- prescribed for SSC academic courses
- OMR cum ICR application forms have to be used for March-2015 Exams which will be supplied to schools
- The candidates belonging to Scheduled Castes / Scheduled Tribes and Backward classes who are appearing for SSC March-2015 for the first time as Regular candidates and whose parental income does not exceed Rs.24000/- per annuam in urban areas and Rs 20000/- or land holding not exceeding 2.5 acres wet land , 5 acres dry land in rural arrears are exempted from the payment of examination fee . As such the headmaster are requested to satisfy themselves about the parental income by insisting upon a certificate by the Mandal Revenur Officer as per rules.
