## FREQUENTLY ASKED QUESTIONS (FAQs)

## 1. How should I submit the Application form for TS EAMCET-III-2016?

There is no need to apply for TS EAMCET-III-2016 separately. Only those candidates who have earlier registered for TS EAMCET-II-2016 and have a valid <u>Registration number</u> (against his/her name) issued by TS EAMCET-II-2016 office earlier are <u>ELIGIBLE</u> to write the TS EAMCET-III-2016 scheduled on 11-09-2016. Please visit the EAMCET website www.tseamcet.in for more details.

### 2. Is there any Registration fee to be paid towards TS EAMCET-III-2016 examination?

There is no need to apply for TS EAMCET-III-2016 again. However, if you have already applied for TS EAMCET-II-2016 (Medical), then the earlier paid **Registration fee** and **Registration number** are valid for TS EAMCET-III-2016 as well.

# 3. I have applied for TS EAMCET-II-2016 but due to various reasons was ABSENT for the test, can I appear for TS EAMCET-III-2016?

Yes, only those candidates who have earlier <u>registered</u> for TS EAMCET-II-2016 and have a valid <u>Registration number</u> (against his/her name) issued by TS EAMCET-II-2016 office earlier are <u>ELIGIBLE</u> to write the TS EAMCET-III-2016 scheduled on 11-09-2016.

### 4. What should I do with the "Filled In Application Form"?

By using the **TS EAMCET-II-2016** <u>"Registration Number"</u> the candidate has to take a print of the "Filled In Application Form", keep a copy of this form and preserve it carefully. Use the same Registration number printed in the "Filled In Application Form" for all future correspondence. **ALL** the candidates have to submit the Filled In Online Application Form to the Invigilator in the Examination Hall.

## 5. Should I upload any certificates?

No, you do not have to upload any certificates. However, **ALL** the candidates have to submit the Filled In Online Application Form to the Invigilator in the Examination Hall. If the candidate belongs to SC / ST category, then he/she needs to submit a duly attested photocopy of the Caste Certificate to Invigilator in the examination hall along with a copy of the Filled In Application Form in case the required Application Number of their Caste Certificate (in case of SC / ST) is not furnished at the time of Submission of the Online Application Form.

### 6. I belong to BC category, should I also enclose the category certificate?

BC or OC candidates need NOT submit any certificates. ONLY SC / ST category students have to submit the duly attested photo copy of the Caste Certificate along with the Filled In Application Form to the Invigilator in the Examination hall during the TS EAMCET-III-2016 test. However, BC students have to produce the Category Certificates at the time of admission.

### 7. What are the Boxes given in the bottom of the Filled in Online Application form?

The boxes at the bottom of the Filled In Online Application Form are meant for affixing photograph, signing and place thumb impression of the candidate. A recent passport color photograph of the candidate has to be affixed and attested (by a Gazetted Officer / the Principal of the College where the candidate has last studied) in the appropriate box before coming to the examination hall. The Signature and Left hand thumb impression of the candidate have to be done at the designated places on the Filled In Online Application form should be done during the examination in the presence of the Invigilator.

### 8. Do I need to post my application and attachments?

No, Not Necessary.

# 9. I did some mistake in filling the details in Online Application during TS EAMCET-II-2016, then how to change?

The candidates are highly expected to be extra careful while filling the ONLINE application form. There is no chance for editing the data in the Filled In Online Application Form at this stage of the examination.

## 10. If I misplace my copy of the "Filled In Online Application Form", how to get another copy of it?

You can take a fresh printout of the "Filled In Online Application Form" from the website **www.tseamcet.in** by giving suitable details.

### 11. I have missed to take a print of my ONLINE application at the end of my application process. How will I get access to it?

You can take a copy by typing the Registration number and Qualifying Examination Hall Ticket number and take a printout from the **www.tseamcet.in** by clicking "Print Your Filled In Application Form".

## 12. My Registration No. is lost, whom should I contact?

If your Registration No. is lost, click the "Forgot Registration Number", contact your nearest Regional Coordinator / TS EAMCET-III-2016 office. For more details visit the website : **www.tseamcet.in**.

## 13. I forgot to Affix the recent color photograph and attestation by Gazetted Officer on the Filled In Online Application Form, what should I do?

The candidate is expected to doubly ensure that the color photograph is affixed and attested by the Gazetted Officer / Principal of the College well in advance before the Examination, as it is **mandatory** to submit the same to Invigilator in the examination hall.

## 14. You said Filled In Online Application Form is not a Hall Ticket, hence, I somehow forget it to bring to the Examination Hall.

It is mandatory to submit the duly attested Filled In Online Application Form to the Invigilator in the examination hall or else you will not be **ALLOWED** to take the TS EAMCET-III - 2016 test.

# 15. If I arrive to the TS EAMCET-III- 2016 Examination Hall late by 1 minute, will I be allowed to take the exam?

The candidate aspiring for TS EAMCET-III- 2016 examination will **NOT BE ALLOWED** into the examination hall if he/she is <u>late even by 1 minute</u>. Hence, there is no scope for taking the exam. In view of the unwanted situations in the past, the candidates are advised to reach the Test Centre well in advance keeping in view the time required for traveling and traffic conditions.

# **16.** I have paid the Registration Fee for the Medical stream, but I do not wish to take the TS EAMCET-III- 2016 exam due to unavoidable reasons. Is the Registration Fee Refundable?

No, the Registration Fee once paid is NOT REFUNDABLE.

## **17. Can I exchange the Transaction Id. with my friend?** No, the Transaction Id. is not TRANSFERABLE

## 18. Are the Help Line Centres (HLCs) meant for appearing TS EAMCET – III-2016 entrance test?

No. This information is required for certificate verification at the time of Counseling for admission to professional courses. The schedule will be notified by the competent authority at a later date.

### 19. I haven't found the answer to my question in the FAQ's, what should I do?

The candidate is advised to go through ALL details thoroughly on the official EAMCET - 2016 website **www.tseamcet.in**.
