



## NOTIFICATION FOR RECRUITMENT TO THE POST OF SECURITY SUB INSPECTORS (SSIs)

(1) Applications are invited On-line through website <http://apsrtc.cgg.gov.in> for Direct Recruitment from eligible candidates for filling up 9 Security Sub Inspectors (SSIs) on regular basis in APSRTC, (2) The desirous eligible candidates may apply **ON-LINE** only after satisfying themselves with the eligibility and terms and conditions of this recruitment. Departmental candidates too have to apply **ONLINE** only. Applications submitted other than **ON LINE** will not be entertained.

(3) **METHOD OF RECRUITMENT** : The vacancies will be filled by direct recruitment from the following categories of candidates.

(i) Graduates working in the Security Branch of APSRTC, (ii) Graduates working in AP Police Service (i.e., Civil AP, APSP) in the Executive Branch as Police Constables, (iii) Junior Commissioned Officers of Armed Forces (i.e., Army, Navy and Air Force) who are honourably discharged or retired from service and below 45 years of age, (iv) Graduate sportsmen represented AP State in the nationals in the last 5 years as on the date of Notification, (v) Graduates who are in possession of NCC-C certificate.

**EDUCATIONAL QUALIFICATION :-** (a) Must be a Graduate of a recognized University; (b) Must not be less than 1M - 68CMs. in height; (c) (i) In Case of candidates at Sl.No. i, ii, iv & v. under Method of recruitment they must not be above 28 years and below 20 years as on 01-07-2011, (ii) In case of candidates mentioned at Sl.No. iii. under Method of Recruitment they must not be above 45 years of age as on 01-07-2011. (d) In case of candidates at Sl.No. i and ii under Method of Recruitment, the probation in the present post must have been declared. (e) Must not be less than 1M - 64 CMs in height for ST candidates and must not be below 1M - 68 CMs in height for other communities. (f) Must not be below 83 - 80 CMs in Chest on full inspiration with a minimum expansion of 5 CMs in respect of ST candidates and must not be below 87 CMs in full inspiration with minimum expansion of 5 CMs in respect of other communities. (g) In case of Women candidates - Must not be less than 152.5 CMs in height and must not be less than 45.5 Kgs in weight. **Note** : The other conditions prescribed for SSI posts for men candidates shall be applicable to women candidates also.

**AGE :-** 1. In case of SC/ST/BC candidates the upper age limit is relaxable by 5 years. 2. Reservation for BC-E group will be subject to adjudication of the litigation pending before the Hon'ble courts and Government orders from time to time. 3. Number of posts mentioned above are provisional. They may vary upwards or downwards. 4. Candidates who acquired qualification up to last date of submission of applications need only apply. 5. PHC candidates are not eligible for the post.

(4) **HOW TO APPLY :-** The Notification with break-up of vacancies, Scale of Pay, Age, Community, Educational qualifications, procedure for applying **ON LINE** and other instructions may be viewed in the 'User Guide and Instructions Booklet' on the Website <http://apsrtc.cgg.gov.in> from 13.03.2012. (5) **FEE** : The fee to be paid is shown in the table below. The fee shown includes both 'Application fee and Examination Fee'. The fee can be paid at any AP Online Centre.

**FEE STRUCTURE** : OC candidates : Application fee : 200, Examination fee : 200, Total fee to be paid : 400; SC/ST/BC, Ex.service candidates & Departmental, Emp. : Application fee : 200, Examination fee : NIL, Total fee to be paid : 200.

**NOTE** : Candidates belonging to States other than Andhra Pradesh will be considered in general category only and are required to pay the prescribed fee applicable to OC candidates.

(6) **IMPORTANT DATES FOR FEE PAYMENT AND APPLICATION SUBMISSION** : Starting date for payment of Fee at any AP OnLine center - 13-03-2012, Starting date for filling and uploading **ONLINE** application is - 14-03-2012, Last date for payment of Fee is - 30-03-2012 up to 5.00 P.M. Last date for uploading of Application is - 02-04-2012 up to 5.00 P.M.
