PRE MEDICAL ENTRANCE EXAMINATION (PMEE) 2012

HIHT University invites application from eligible candidates for admission into MBBS course offered by Himalayan Institute of Medical Sciences for the Academic Year 2012 - 2013. Total seats 100 out of which 30% seats are earmarked exclusively for the domiciled candidates of Uttarakhand.

ELIGIBILITY- Age: Only those candidates, whose date of birth falls on or before 31st December, 1995 (minimum 17 years of age as on 31st December, 2012) are eligible to apply. **The upper age limit shall be 25 years as on 31/12/2012. Minimum Qualification:** The candidate must have passed the 10+2, i.e. C.B.S.E./I.S.C/Intermediate board examination or its equivalent, after a period of 12 years of study, the last two years of such study, comprising of **Physics, Chemistry, Biology/Biotechnology and English from a recognized Board** and must have obtained a minimum of 60% (for SC/ST/OBC candidates 50%) marks in aggregate in Physics, Chemistry and Biology/Biotechnology taken together and at least 50% (for SC/ST/OBC candidates 40%) marks separately in each of the above subject. **The candidates who are appearing for the qualifying examination are also eligible to appear in the PMEE-2012 but such candidates should submit the mark sheet of the qualifying examination on or before 10th June 2012.**
