- **Maximum Age Limit:** Age as on 30.5.2013 shall not exceed 35 years.
- **Minimum Qualification:** Recognized Graduation Degree or Diploma in any branch of Engineering and possesses degree or diploma in Industrial safety recognized by the State Government.

OR

Recognized (Graduation) Degree in Physics or Chemistry and possesses degree or diploma in Industrial safety recognized by the State Government.

- **Experience:** Minimum TWO years practical experience of working in a factory in a supervisory capacity, if the applicant possesses a recognized degree in any branch of engineering with degree/diploma in Industrial safety recognized by the State Govt.

OR

Minimum FOUR years practical experience of working in a factory in a supervisory capacity, if the applicant possesses a recognized diploma in any branch of engineering with degree/diploma in Industrial safety recognized by the State Government.

OR

Minimum SIX years practical experience of working in a factory in a supervisory capacity if having a recognized graduation degree in Physics or Chemistry and possesses degree/diploma in Industrial safety recognized by the State Government.

- **Emoluments:** Scale of pay – **Rs.13,900-24,000/-**  
Besides basic pay, Dearness Allowance, Perks/Allowances and other benefits like EPF, Employees Pension, EDLI, Corporation's accommodation or HRA, leave and medical benefit to self and dependents etc. as per the rules of the Corporation from time to time shall also be admissible.
