All the candidates who have appeared in the examination conducted by NIFT for admission to '**Bachelor of Fashion Technology (B.F.Tech.)**' and '**Bachelor of Design (B.Des.)**', and they have been assigned **a merit rank** as per their performance in examination for admission to UG Programmes, are hereby given an opportunity to take admission in the vacant NRI seats.

3. The status of vacant NRI seats in Bachelor of Design (B.Des.) programme is being uploaded at NIFT website each day as regular counselling for B.Des. is in progress. Apart from the available vacant NRI seats, an additional batch of 30 candidates in B.Des. (FD) is hereby offered at NIFT Gandhinagar for all the candidates having a merit rank as explained above. This opportunity is also available to the students who have taken admission in any Design course other than FD across all NIFT campuses. Interested candidates may approach Director, NIFT Gandhinagar or the campus where they registered for counseling for change with all relevant documents.
4. The candidates interested to take admission in the vacant NRI seats may attend the counseling for submission/ verification of documents on **11th July, 2013 at 11.00 AM** at their nearest NIFT Campus. The seats will be allotted on **12th July, 2013 at 9.00 AM** as per merit rank. For further the

information candidates may contact the Campus Directors / Joint Directors, in person. Seats will be allotted as per common merit rank.

5. The mandatory documents required at the time of Counselling / admission to take admission under the category '**Children / Wards of NRI**' are as under :

- a) Application Form
- b) An undertaking from PIO/Foreign National/SAARC and NRI.
- c) Attested copies of relevant pages of Passport of PIO/Foreign National/SAARC and NRI.
- d) Demand Draft of Rs.4,76,000/- in favour of NIFT payable at the Centre the candidate attending the counselling at the time of Counselling / admission.
- e) Demand Draft of Rs.3000/- in favour of NIFT payable at the Centre the candidate attending the counselling at the time of Counselling / admission.

6. The list of other necessary documents required at the time of counselling are as under:

- 1) Print out of the result indicating the common & category merit rank
- 2) Two Passport size and four stamp size photographs
- 3) 10th Mark sheet and Certificate
- 4) 10+2 Mark sheet and Certificate or any other eligibility certificate as mentioned in the prospectus. (PCM for B.F.Tech. Programme)
- 5) Medical Fitness Certificate in prescribe format (**Annexure I**)
- 6) Undertaking for Anti-ragging (**Annexure II**)
- 7) An undertaking regarding refund/withdrawal from the candidate (**Annexure-III**)
- 8) Authorization Letter in case candidate is not attending Counselling in person (**Annexure IV**)
