#### **Notice for Document Verification**

On the basis of written examination held on 16.10.11 at Hubli-Dharwad, Bangalore and Mysore for the above recruitment, candidates bearing the following Roll Numbers are being called for verification of their original documents, i.e. original certificates in support of their educational qualification, proof of age, disability certificate, community (SC/ST/OBC) etc, tallying the same with details and documents submitted in their original application, and checking their admit card, photograph, signature and handwriting etc.

The list is arranged in ascending order of Control Numbers (in brackets) corresponding to the Roll Numbers. The numbers in brackets are the Control Numbers (same as printed in the hall tickets). These numbers are not in the order of merit. The candidates are directed to report for the said verification as per schedule (of date & time) given, to Railway Recruitment Cell, DRM's Office Compound, Hubli – 580 020.

The candidates are required to bring the following **original** documents (along with one attested copy of each) for verification for the purpose of establishing age, date of birth, educational qualification, disability certificate and community status.

# (1) Educational Qualifications:

- (a) 8<sup>th</sup> class pass certificate, marksheets, School Leaving Certificate (for below class X pass),or
- (b) Matriculation certificate, (for those passed class X or above), and
- (c) Any higher qualification certificate

# (2) Date of Birth:

- (a) School Leaving Certificate, marksheets (for those below X class passed) or
- (b) Matriculation certifiate (for those passed class X) or
- (c) Any other relevant certificate.

# (3) SC/ST/OBC certificate:

(a) SC/ST certifiate in prescribed proforma as printed in Employment Notification No.01/2007(PHQ) signed by the appropriate competent authority.

(b) OBC certifiate including certification of non-creamy layer as per proforma printed in Employment Notification No.01/2007(PHQ) signed by the appropriate competent authority (issued in the current year).

## (4) **Disability Certificate:**

Further to the conditions laid down in Para 2 (ii) of the Employment Notice No.1/2007(PHQ), the following is laid down in terms of Railway Board's extant instructions in regard to physical disability certificate.

- (a) The Disability Certificate produced should be issued by Medical Boards duly constituted by the Central/State Government consisting of at least three members out of which at least one member has been/should be a specialist in the relevant field for assessing locomotor/cerebral/visual/hearing disability, as the case may be.
- (b) The Disability Certificate would be valid for period of 5 years for those whose disability is 'Temporary'. The Medical Board shall indicate the period of validity of the Certificate where there are chances of variation in the degree of disability. For those with permanent disability the validity can be shown as 'Permanent'.
- (c) The physical disability certificate has to be produced in the format enclosed as Annexure. The eligibility criteria for consideration for recruitment against PHQ, a candidate has to have physical disability of not less than 40%.

## (5) Other documents to be brought:

- (a) Original call letter of written examination,
- (b) Attested copies of all relevant certificates(one each), and
- (c) Three passport size photographs.

**Note:** It is made clear that merely being called for document verification does not in any way entitle or confer on a candidate the right to an appointment in the Railways.

The candidates are being individually intimated by post. Railway Recruitment Cell/Hubli will not be responsible for any postal delay, wrong delivery or loss in transit if any.

In case any candidate does not receive the call letter for document verification, he/she can still attend the office as per given schedule along with the original documents asked for.

Any candidate coming for verification without all required and relevant documens will not be entertained.

While every care has been taken in preparing the list, the Railway Recruitment Cell/Hubli reserves the right to rectify errors and commissions if any, if detected during the course of document verification or thereafter.

The candidates whose documents and certificates are found to be in order will be directed for medical examination shortly thereafter.

Please beware of unscrupulous elements who may misguide the candidates with false promises of getting them selected for the job, on illegal consideration. The recruitment process in the RRC exams is fully computerised and the selection is based purely on the merit of the candidates.

Note: (i) According to the Persons With Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Ruels,1996 notified on 31.12.1996 by the Central Government in exercise of the powers conferred by sub-section (1) and (2) of Section 73 of the Persons With Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act 1995 (1 of 1996), authorities to give disability certificate will be a Medial Board duly constituted by the Central or the State Government. The State Government may constitute a Medical Board consisting of at least three members out of which at least one shall be a specialist in the particular field for assessing locomotor/hearing and speech disability, mental retardation and leprosy cured as the case may be. (ii) The certificate would be valid for a period of 5 years for those whose disability is temporary. For those who acquired permanent disability, the validity can be shown as permanent.
