- (a) who retired from such service after earning his/her pension. This would also include persons who are released/retired on their own request but after having earned their pension; or
- (b) who has been released from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension, or
- (c) who has been released, otherwise than on his own request from such service as a result of reduction in establishment, or
- (d) who has been released from such service after completing the specified period of engagements, otherwise than at his own request or by way of dismissal or discharge on account of misconduct or inefficiency, and has been given a gratuity and includes personnel of the Territorial Army of the following categories:-
 - (1)Pension holders for continuous embodied service.
 - (2)Persons with disability attributable to military service.
 - (3)Gallantry award winner.
- **NOTE-III** As per D/o Personnel & Training O.M. No.36034/6/90-Estt.SCT dated 2.4.1992, such Ex-servicemen who have already joined government job in civil side after availing of the benefits given to ex-servicemen for their re-employment are also eligible for the age concession. However, such candidates will not be eligible for the benefit of reservation as EXS or for fee concession.
- **NOTE-IV** The period of call up Service of an EXS in the Armed Forces shall also be treated as service rendered in the Armed Forces . For any servicemen of the three Armed Forces of the Union to be treated as EXS for the purpose of securing the benefits of reservation, he must have already acquired, at the relevant time of submitting his application for post/service, the status of EXS and/or in a position to establish his acquired entitlement by documentary evidence from the competent authority that he would complete specified term of engagement from the Armed Forces within the stipulated period of one year from the **closing date (27.02.2012)**

PROCESS OF CERTIFICATION/FORMATS OF CERTIFICATES:

The State government may constitute a Medical Board consisting of at least three members out of which at least one shall be a specialist in the particular field for assessing locomotors / hearing and speech disability, mental retardation and leprosy cured, as the case may be.

Note-III: Central Govt. Civilian Employees claiming the benefit of Govt. employees, would be required to submit a certificate (**as per Annexure-VII**) by their office indicating length of service at the time of applying for the examination to enable the Commission to decide their eligibility.
