6. The students should submit their Examination forms to the Principals concerned.
7. The students should write their name correctly in the examination form as per their Degree certificates (other than integrated course) or Inter certificate(5YIPGP).

**Following is the schedule for submission of application forms and nominal rolls.**

- A. Application forms along with
  - (i) 3 hard copies of nominal rolls in the prescribed proforma.
  - (ii) 'No Dues Certificate' from the Academic Audit Cell, T.U.
  - (iii) 'No Dues Certificate' from Dean, College Development Council, T.U.
  - (iv) Should reach the Controller of Examinations as per the following schedule
