This includes the originals of all certificates whose xerox copies were attached with the application form for various categories of Section Engineer/CDMS (b) vacancies are available (c) they pass prescribed medical examination (d) complete the requisite administrative formalities/procedures and (e) their thumb impression, photograph, signature, handwriting and other details in their applications match before appointment/actual joining.

All successful candidates are also being advised individually.

If at a later date, any candidate is found to be debarred by any RRB or any discrepancies/irregularities detected in respect of qualification, age community etc, then his candidature/appointment will be cancelled.

The list indicating Roll Numbers in ascending order of candidates who remain absented even after providing 2nd chance by intimating them through registered post with AD is attached as **ANNEXURE-II**. The candidature of these candidates stands cancel.
