**IMPORTANT THINGS TO NOTE:**

1. **The candidate is expected to write 100 marks examination for each paper.**
2. Continuation fee - Rs.1,000/- per year is to be paid after completion of 2 years of registration. (The same has to be remitted along with the examination fee). Need not pay the continuation fee if paid already during June 2011 examination.
3. **Students attending the examination will have to make their own arrangements for accommodation.**
4. All payments (examination fee, late fee & continuation fee whichever is applicable)
  - a. shall be made in a single DD, favouring **Registrar, NLSIU, payable at Bangalore.**
  - b. Payments may also be made in cash through at the NLSIU Cash Counter, on all working days (Monday to Saturday) between 9.30a.m and 4.00p.m.
  - c. Submission of application & payment can be done online from October 10, 2011.
